
The brief facts of the case are as follows:-

The appellant vide his RTI applications dated 30.10.2023 had sought information under RTI Act, 2005.

The Case was fixed for hearing on 29.12.2023 in the office chamber of the undersigned. The appellant was not present. The PIO was also not present. The case was represented by Sh. Rajesh Kumar, APIO, Associate Professor (English), Govt. College Rampur Bushehar. The case was heard on merit. The Appellant in his appeal submitted that he did not get any reply within time limit from PIO. APIO in his statement stated that due to technical issues for login in the portal, information could not be provided to the applicant. But, now issue has been resolved and desired information has already been supplied to the applicant vide his office letter No. 1060 dated 22.12.2023 and further admitted that such type of mistake will not be repeated in future. He stated in his statement that appellant has now received the information and is satisfied with the information. Appellant has now withdrawn his application.


After perusal of the record and as per statement of the APIO, it is found that information as sought by the appellant, was provided to the appellant and appellant also admitted the fact and satisfied with the information.
